### **Group Work Expectations**

### Jigsaw Review Session

### **Expert Group**

- As a group, come up with a five minute "lesson" on your topic. USE ACADEMIC LANGUAGE.
- You lesson <u>must</u> include the following criteria
  - A definition/explanation of the topic.
  - A visual (model, drawing, graph, etc.) An explanation of WHY this concept occurs, or evidence of a phenomena (ex. Gold foil experiment).
  - An analogy, is possible.
  - Where SPECIFICALLY in the book AND your notebook your topic is found.
- All group members must have the SAME INFORMATION written down, so you must collaborate. Page 87
- You have <u>20 Minutes.</u>

## Jigsaw Group

#### Example of Part 1:

  - What is the chemical(s) in frankincense?
  - How much of that chemical is lethal or harmful?
  - What company distributes this essential oil?
  - What is the dosage in one drop?
  - Could this be a harmful amount?
  - Are there any studies that demonstrate a reduction in cancer cells after being treated with this chemical?
  - What DOES destroy cancer cells?
  - Can this chemical be absorbed through the stomach? The intestine? Does is make it to the bloodstream at all?
  - Etc.
